# Stanford City Council Public Hearing & Regular Council Meeting Lincoln County Public Library Meeting Room 6:15 pm, September 14<sup>th</sup>, 2023

## I. Call to Order, Welcome, Pledge and Prayer

Mayor Miller called to order the Public Hearing and Regular Council Meeting of the Stanford City Council at 6:15pm on Thursday, September 14<sup>th</sup>, 2023. All recited the pledge to the U.S. Flag after which Councilman Joe Tackett opened the meeting in prayer.

#### II. Roll Call

A roll call was conducted with the following members present: Eddie Carter, Ronnie Deatherage, Jason Hignite, Joe Tackett and Jerry Wilkinson. Absent was Bill Miracle. A quorum was declared by the Mayor.

Also present were: City Attorney John Hackley, Police Chief Zach Middleton, Chief Scott Maples and Amanda Moss, manager of Oakview Apartments.

# III. Possible 2<sup>nd</sup> Reading of Ordinance T2023 Ordinance Setting 2023 City of Stanford Tax Rates on Real & Personal Property

Motion was made by Councilman Wilkinson (2<sup>nd</sup> by Councilman Hignite) to have the 2<sup>nd</sup> reading of Ordinance T2023 Ordinance Setting 2023 City of Stanford Tax Rates on Real & Personal Property. All in favor, motion carried. City Attorney Hackley made the 2<sup>nd</sup> reading.

Motion was made by Councilman Wilkinson (2<sup>nd</sup> by Councilman Carter) to enact Ordinance T2023 Ordinance Setting 2023 City of Stanford Tax Rates on Real & Personal Property. All in favor, motion carried.

## V. Approval of Minutes

#### IV. Citizen's Comments

Jordan Shaffer asked if the speed bump could be replaced on River Drive at Logan's Trace. Mayor Miller stated that he thinks the speed bump on River Drive was actually supposed to be located on Logan's Trace's property. We do not have speed bumps on city streets. The City still has that speed bump, and he will contact the manager of Logan's Trace and ask them to place it on their property.

Amanda Moss asked about adding a crosswalk at the major intersection of 150 and 127. Mayor Miller shared that the request can be made to the State, and he will bring that up at his next meeting with them.

#### V. Council Comments

Councilman Carter asked about the Foster Lane Project. Mayor Miller shared that we are waiting on State approval after the percentage of bidders under the Disadvantaged Bidders requirement is calculated.

Councilman Deatherage asked about the request from the daycare on Danville Avenue concerning adding a crosswalk to the Elementary School at Cane Run and Old Fort Blvd. A contractor is coming to look at the project and give us a bid on stripping.

Councilman Tackett stated that he got to ride in the new Durango with Officer Milburn and was asked to express the officer's appreciation for approving that purchase. Coming from a 6'3" officer, he greatly appreciates the added room as well as how much better the vehicle handles in the rain. It has also greatly enhanced his sightline into vehicles when making traffic stops.

Mayor Miller also encouraged all council members to look at the new Command Vehicle Durango at the Fire Department.

# VI. Possible 2<sup>nd</sup> Reading of Ordinance 520.7 Bicycle, Skateboard and Horse Ordinance at the request of Councilman Wilkinson

Motion was made by Councilman Carter (2<sup>nd</sup> by Councilman Tackett) to have the 2<sup>nd</sup> reading of Ordinance 520.7 Bicycle, Skateboard and Horse Ordinance. All in favor, motion carried. City Attorney Hackley made the 2<sup>nd</sup> reading.

Motion was made by Councilman Carter (2<sup>nd</sup> by Councilman Hignite) to enact Ordinance 520.7 Bicycle, Skateboard and Horse Ordinance. All in favor, motion carried.

### VII. Update from Chief Middleton

-Chief Middleton was asked to share about the recent meeting with the school board. Details are outlined in his letter to the council included in the September packet. The school board voted to fully fund the SRO division, which means adding three more officers. They have also agreed to buy two, possibly three, cars for these officers. With this said, every car that we have will be in use and there will not be an available pool car if there are any issues with the current fleet. The City has found (2) fully equipped vehicles that are available for purchase from the City of Lancaster. Mayor Miller and Captain Kirkpatrick went to look at the vehicles. Councilman Deatherage asked if this would not be a good purchase for the department regardless of what the school board purchases.

After some discussion a motion was made by Councilman Deatherage (2<sup>nd</sup> by Councilman Tackett) to purchase (2) Ford Explorers from the City of Lancaster for \$25,000 each. All in favor, motion carried.

#### VIII. Mayor's Information to Council

- -4<sup>th</sup> Monday Monthly Muster, invited all to come meet the veteran's, the meeting is part of the Suicide Coalition initiative.
