

**Stanford City Council
Regular Council Meeting
Lincoln County Public Library Meeting Room
6:30pm, June 9th, 2022**

I. Call to Order, Welcome, Pledge and Prayer

Mayor Miller called to order the Regular Council Meeting of the Stanford City Council at 6:32pm on Thursday, June 9th, 2022. All recited the pledge to the U.S. Flag after which prayer was led by Councilman Ronnie Deatherage.

II. Roll Call

A roll call was conducted with the following members present: Ronnie Deatherage, Sara Givens, Jason Hignite, Bill Miracle and Joe Tackett. Absent was Eddie Carter. A quorum was declared by the Mayor. Also present were: City Attorney John Hackley, Fire Chief Scott Maples, Police Chief Zach Middleton, Officer Andy Ferguson and Detective Ryan Kirkpatrick and Joe Gilliland.

III. Approval of Minutes

Motion was made by Councilman Tackett (2nd by Councilwoman Givens) to accept the minutes from the May 12th, 2022 Regular City Council Meeting as written. All in favor, motion carried.

IV. Citizen's Comments

There were no citizen's comments.

IV. Council Comments

There were no council comments.

V. Recognition of 2022 Citizen's Police Academy Graduates

Chief Middleton shared with the council that the PD just completed the first Citizen's Police Academy and had a very successful program. They started with 7 enrolled and ended with 4 graduating. Detective Ryan Kirkpatrick introduced two of the graduates and invited everyone to come out and attend the next academy. He thanked the council for their support of the program. They are also working with the school system to possibly start a Jr Academy. Mayor Miller shared that he has spoke to Mr. Rowe about a program that would be implemented with the school that they are very excited about.

Two of the four graduates attended the council meeting and shared their thanks to everyone who helped to put on this program. They have a new found respect for the officers and what they go through on a daily basis.

Officer Andy Ferguson shared the courses presented included training on performing traffic stops, force on force options, shooting simuniton, School Resource Officers, Alcoholic Beverage Control Administration, investigations, fingerprinting, etc. They are now eligible to do ride along with the Chief's approval.

VI. Resolution 2022-0609 Surplus Property Declaration

A trailer originally included in the resolution was removed because it was determined that there was a need for it with the police department. Also a need arose with a sister agency for the police vehicle that

was being surplused so the resolution was changed to reflect the agency to agency transfer. Mayor Miller read the resolution.

A motion was made by Councilman Deatherage (2nd by Councilman Miracle) to accept Resolution 2022-0609 as presented. All in favor, resolution carried. Mayor Miller read the resolution. Transfer of the Ford Crown Victoria will be made to the Lincoln County Fiscal Court for use by Constable Delbert Mitchell, and the surplus tower will be advertised in the Interior Journal and sealed bids will be accepted.

VII. Proposed 2nd Reading of the City of Stanford Burn Ordinance

A motion was made by Councilwoman Givens (2nd by Councilman Deatherage) to have the 2nd reading of Ordinance 310.5 An Ordinance Relating to Open Burning within the City of Stanford, Kentucky. All in favor, motion carried. Attorney John Hackley made the 2nd reading of the summary.

A motion was made by Councilwoman Givens (2nd by Councilman Miracle) to accept the 2nd reading of the Stanford Burn Ordinance. All in favor, motion carried. The Ordinance will go into effect upon its publication in the Interior Journal on May 19th, 2022.

VIII. Proposed 2nd Reading of the City of Stanford Water and Sewer Budget 2022-2023

Motion was made by Councilman Miracle (2nd by Councilman Tackett) to entertain the 2nd reading of the 2022-2023 Water and Sewer Budget. All in favor, motion carried. Mayor Miller made the 2nd Reading.

A motion was made by Councilwoman Givens (2nd by Councilman Miracle) to accept the 2nd reading of the City of Stanford Water and Sewer Budget 2022-2023. All in favor, motion carried. The Ordinance will go into effect upon its publication in the Interior Journal on May 19th, 2022.

IX. Proposed 2nd Reading of the City of Stanford 2022-2023 Budget

Mayor Miller outlined the updates and additions to the budget to include the Worker's Comp, Liability and Property rates, an \$275,000 Grant for the industrial park that was not received in the past fiscal year and the addition of a \$1,000,000 CDBG Sewer Line Project Grant. A motion was made by Councilman Tackett (2nd by Councilwoman Givens) to have the 2nd Reading of the City of Stanford 2022-2023 Budget. All in favor, motion carried. 2nd Reading was made by City Clerk, Jone Allen.

A motion was made by Councilman Tackett (2nd by Councilman Miracle) to accept the 2022-2023 City of Stanford Budget. All in favor, motion carrier. The Ordinance will go into effect upon its publication in the Interior Journal on May 19th, 2022.

X. Mayor's Information to Council


Mayor Miller shared the following dates and information with the council:

- Dedication at Buffalo Springs Cemetery of Col. Ruben Monday, thank everyone who came out. He shared a card of thanks from the Sons of the Union Veterans of the Civil War.
- US 150 Speed Study has been completed. 85% of drivers are within 5 miles of the existing speed limit. 5% were within 5 miles above, 9% are above the acceptable limit. The speed study determined that the speed is within acceptable range. The consensus of council and the PD is that the legal limit is too high for that area.
- Siege was a huge success. A group from an area retirement community also came to tour and enjoyed their outing.

- Cruise-In 5-8 (July 15 and Aug 19, Sept 16 and Oct 21), Scoops on Main 6-9 are back in full swing every month.
