

**Stanford City Council**  
**Special Called Meeting and Work Session**  
**Monday, August 19<sup>th</sup>, 2019**

**I. Call to Order**

Mayor Scottie Ernst called to order the Special Called Meeting of the Stanford City Council at 5:13pm on Monday, August 19<sup>th</sup>, 2019 at Stanford City Hall.

**II. Roll Call**

A roll call was conducted with the following members present: Ella Mae Curlis, Ronnie Deatherage, Dalton Miller and Dr. Naren James (who attended by video conference). Councilmembers Hester and Givens were absent.

Also present were: City Attorney John Hackley and Jamie Mingo.

**III. Motion to Accept the Resolution of the City of Stanford, Kentucky Approving and Authorizing an Assistance Agreement Dated as of August 19, 2019 Between the City of Stanford, Kentucky and the Kentucky Infrastructure Authority**

Motion was made by Councilwoman Curlis (2<sup>nd</sup> by Councilman Deatherage) to accept the Resolution of the City of Stanford, Kentucky Approving and Authorizing an Assistance Agreement Dated as of August 19, 2019 Between the City of Stanford, Kentucky and the Kentucky Infrastructure Authority. City Attorney John Hackley read the resolution. A roll call vote was done with Councilmembers Curlis, Deatherage, James and Miller voted yes. Motion passed.

Motion was made by Councilwoman Curlis (2<sup>nd</sup> by Councilman Deatherage) to adjourn at 5:17pm. With all in favor, the motion carried. Councilman James left the meeting by video conference at 5:17pm.

Those in attendance: Councilmembers Curlis, Deatherage, Miller, Mayor Ernst, and Jamie Mingo, discussed the options for controlling the cat population in the city. The City and County Animal Control Ordinances were discussed and the question of who collects fees, writes citations and who retains fees was asked. The City Clerk will call the County Animal Shelter to find out what animals they accept and what the fees they collect are. That information will be shared with the council at the next regular meeting.

Also discussed was the collection of fees for yard sales and how best to regulate yard sale sign placement.

An index of all City Ordinances was passed out and discussed. It was suggested that the Ordinances be broken down by department and given to that respective department to review and update as needed. Then those departments will bring their findings back to the council.
