**I. Call to Order, Welcome, Pledge and Prayer**

Mayor Miller called to order the Special Council Meeting of the Stanford City Council at 5:00pm, Thursday, December 17<sup>th</sup>, 2020. All recited the pledge to the U.S. Flag after which prayer was led by Councilwoman Sara Givens.

**II. Roll Call**

A roll call was conducted with the following members present: Ella Mae Curlis, Ronnie Deatherage, Sara Givens, and Bill Miracle. Absent were: Councilwoman Peggy Hester and Councilman Naren James. A quorum was declared.

Also present were: John Hackley, City Attorney, and Bridgette Lester, City of Danville ABC Administrator.

**III. 1<sup>st</sup> Reading of City of Stanford, Kentucky Alcoholic Beverage Control Ordinance No: 410.2**

Motion was made by Councilman Deatherage (2<sup>nd</sup> by Councilwoman Curlis) to have the 1<sup>st</sup> reading of City of Stanford, Kentucky Alcoholic Beverage Control Ordinance No: 410.2. All in favor, motion carried. City Attorney John Hackley read a summary he prepared of Ordinance No: 410.2.

Motion was made by Councilwoman Curlis (2<sup>nd</sup> by Councilman Miracle) to approve the 1<sup>st</sup> reading of City of Stanford, Kentucky Alcoholic Beverage Control Ordinance No: 410.2. All in favor, motion carried.

**IV. Municipal Order Relating to Procedures for Administrative Disposition of Alleged Violations of the City of Stanford Alcoholic Beverage Control Ordinance Order No: MO2020-1217**


Decision was made by the council body to lay aside the reading of the Municipal Order until the 2<sup>nd</sup> reading of the City of Stanford, Kentucky Alcoholic Beverage Control Ordinance No: 410.2 is completed.


V. **1<sup>st</sup> Reading of an Amended Ordinance of the City of Stanford, Kentucky Fixing and Establishing the Annual Salary and Compensation for the Elected Office of Mayor of the City of Stanford and for the Elected Office of Councilperson of the City of Stanford for the Term of Office Beginning in January of 2021 and COLA Retroactive to January 2020**

After discussion of the implications of the proposed amendment and consulting KRS 83A.070 as to the legality of the change, the 1st reading died for lack of a motion.
